PhD Planning criteria and assessment

Scientific and professional growth of doctoral students

PhD – Planning and continuous assessment at VUM

Art. 3. The educational and scientific degree "PhD" is awarded by a scientific jury after accumulation of a minimum of 180 credits, and successful defense of the dissertation.

PhD – Planning and continuous assessment

- Art. 4. Credits are formed as a result of
 - (1) Fulfilment of the educational program
 - (2) Fulfilment of the pedagogical activity (teaching)
 - (3) Implementation of a scientific program (publications)
 - (4) Doctoral dissertation
- Art. 5. The mandatory minimum credits for admission to the defense of the dissertation work before a scientific jury is 150 credits.

PhD Pedagogical activities

Art. 7 (1) The curriculum of the doctoral program includes mandatory teaching practice for each doctoral student in full-time education. Doctoral students should cover pedagogical activities with a total of at least 10 ECTS credits.







PhD - Planning and continuous assessment

- Art. 8 (1) The mandatory minimum number of credits from the scientific program is 60 credits.
- (2) A doctoral student may be given the right to defend a dissertation if he/she has collected a minimum of 30 points, in accordance with the Minimum Requirements for the Academic degree "PhD"
- (3) 1 point is equivalent to 2 ECTS credits according to the doctoral program curriculum

PhD - Planning and continuous assessment

(4) The points are formed from:

- Published monograph, which is not the main habilitation work 100 points
- ➤ Published book based on a submitted dissertation work for the award of the educational and scientific degree "PhD" 75 p.
- Articles and reports published in scientific journals, referenced and indexed in world-renowned databases of scientific information, e.g., Scopus, Web of science – 30 points/each
- Articles and reports published in non-refereed journals with scientific review in edited collective volumes 10p/each

PhD – Planning and continuous assessment

- (4) The points are formed from (cont.):
- Studies published in scientific journals, referenced and indexed in world-renowned databases of scientific information - 45/n
- ➤ Studies published in non-refereed journals with scientific review or published in edited collective volumes 15/n
- ➤ Published chapter of a collective monograph 20/n

PhD – Planning and continuous assessment - Defense

- Art. 9. The minimum required credits for the defense of PhD thesis are 60 credits. They are formed by
- (1) Participation in doctoral seminars and courses 10 credits
- (2) Presentation of the thesis for internal discussion at the Department 20 credits
- (3) Defense of the doctoral dissertation before a scientific jury 30 credits.
